

In accordance with the settlement agreement between the United States and the City of Philadelphia, and the settlement between the parties in the above-captioned case, the United States provides this bi-monthly report for the period of February 1, 2010, to March 31, 2010, on the status of the United States' polling place surveys.

This report provides only a summary of the actual survey results. Copies of the surveys have been provided to all the parties. If the Court would like further information, copies of surveys can be provided as well.

ACCESSIBLE POLLING PLACES

The following polling places have been surveyed by the United States and have been determined to be accessible under the standards agreed to in this case. We indicate the ward, division, name, and entrance location of each polling place. For these polling places, the main entrance used by voters on election day is also the accessible entrance.

- Ward 34, Division 20, Overbrook Education Core Building (N. 68th Street)
- Ward 39, Divisions 10, 19, Jackson Place (Jackson Place)

POLLING PLACES THAT MAY BE MADE TEMPORARILY ACCESSIBLE ON ELECTION DAY

The following polling places have been surveyed by the United States and have been determined to be inaccessible under the standards agreed to in this case. For these polling places, there is a temporary measure(s) that may make them accessible on election day. We include the temporary measures as well as the identification of the polling places and the primary entrance. Additionally, when there is an alternate accessible entrance, we indicate whether the accessible entrance should not be re-designated as the exclusive entrance and signs should be posted directing voters to the accessible entrance, or whether the accessible entrance should be re-designated as the exclusive entrance. If an alternate entrance is not indicated, then the primary entrance and the accessible entrance are the same entrance.

Also included in this category are polling places that are otherwise accessible but the accessible entrance is not the primary entrance; a recommendation to re-designate the accessible entrance as the exclusive entrance is provided as a temporary remedy.

Additionally included in this category are polling places that are accessible but require signs to be posted to direct voters to an accessible entrance when it cannot be re-designated as

the exclusive entrance. We include the reason why the accessible entrance should not be re-designated as the exclusive entrance.

Finally, we have included recommendations for permanent modifications for publicly-owned buildings where it may be reasonable to modify inaccessible features. Where appropriate, we have provided a recommendation as to how they may be reasonably, permanently modified to remove barriers to accessibility.

- Ward 3, Division 6, Garage/Office (Primary Entrance: S. 62nd Street door; Accessible Entrance: Garage door)

1. Re-designate the accessible entrance as the exclusive entrance.
2. Keep garage door open.

- Ward 4, Division 21, Overbrook High School (Primary Entrance: Oxford Street; Accessible Entrance: 59th Street ramped door)

1. Re-designate the accessible entrance as the exclusive entrance.
2. Relocate voting area to the first floor.

- Ward 5, Division 20, Rodriguez Branch Library (Primary Entrance: Girard Avenue entrance door; Accessible Entrance: Girard Avenue exit door)

Temporary Measures:

1. Re-designate the accessible entrance (the “exit”) as the exclusive entrance.
2. Prop open interior vestibule door.

Permanent Measures:

1. Install automatic doors.
2. Move metal “eye” at the side of the turnstile (at entrance) to the back of the turnstile.

1. Place 1 foot square metal plate on top of cavity in asphalt.

Permanent Measure:

 1. Relocate voting area to the garage.

 4. Place 1.5 inch wedge or threshold ramp on both sides of 2 x 8 sill plate at garage door.

 1. Re-designate the accessible entrance as the exclusive entrance.

 3. Prop open interior doors to voting location in basement.
 4. Relocate all voting areas to the basement until such time as the elevator is repaired and functional.

 1. Prop open door to voting area in the Comprehensive Daycare Room.
 2. Prop open door to voting area in the Fitness Center.
 3. Relocate voting area from the Music Room to the hallway.

- Ward 39, Divisions 5, 6, Furness School (Primary Entrance: Mifflin Street side gym entrance; Accessible Entrance: McKean Street ramped entrance)
 1. Re-designate the accessible entrance as the exclusive entrance.
 2. Prop open the door at the McKean Street ramped entrance.
 3. Relocate voting area to the cafeteria.
- Ward 39, Divisions 29, 44, JP Caterers (9th Street double doors to the right of awning)
 1. Prop open one leaf of double doors at entrance.
- Ward 41, Division 1; Ward 62, Divisions 2, 3, Sullivan School (Ditman Street (door marked 5300 overhead))

Temporary Measures:

1. Remove astragal from entrance door.
2. Prop open both doors.
3. Place 6 foot temporary ramp from the pavement over the steps to the threshold of the door.
4. Relocate all voting areas to the classrooms adjacent to the Ditman Street entrance.

Permanent Measures:

1. Raise exit platform at doors to floor level and remove concrete to make a level landing.
 2. Install permanent, compliant ramp at least 6 feet long.

 1. Re-designate the accessible entrance as the exclusive entrance.

Pastor's Reception Area (Primary Entrance: Glass single door at 1519 52nd Street; Accessible Entrance: 52nd Street double doors with 1513-17 on top; once inside, there is an interior ramp to the voting area)

1. Re-designate the accessible entrance as the exclusive entrance.
2. Prop open double doors with 1513-17 on top.
3. Prop open interior door to Pastor's Reception Area.
4. Place mat over 1 inch level change at interior entrance to reception area.

Fellowship Hall (Primary Entrance: 52nd Street double doors with 1513-17 on top, once inside, there are stairs to the voting area; Accessible Entrance: 52nd Street double doors with 1507-11 on top)

1. Do not re-designate the accessible entrance as the exclusive entrance as there is a daycare program at the accessible entrance and the church has expressed security concerns.
2. Post signs at the primary entrance and at the accessible entrance indicating location of the accessible entrance.

POLLING PLACES THAT ARE INACCESSIBLE AND SHOULD BE RELOCATED

The following polling places have been surveyed by the United States and have been determined to be inaccessible under the standards agreed to in this case. The United States has further determined that temporary measures cannot be implemented to make the polling places accessible on election day. For this group of polling places, we recommend that each polling place be relocated to an existing polling place location or to another site. If the City determines that the relocation of a particular division is not possible, then the United States will continue to work with the City to locate an alternative location for the division.
