# CITY DEFENDANTS' TENTH SET OF RESPONSES TO THE THIRD-PARTIES' ACCESSIBILITY RECOMMENDATIONS FOR POLLING PLACE LOCATIONS

The City of Philadelphia (the "City"), Margaret M. Tartaglione, Anthony Clark and Joseph Duda, (collectively, the "City Defendants") submit to the Court this report providing the City Defendants' responses to 218 recommendations issued by the independent third parties, the Department of Justice and Campbell Thomas & Company (collectively the "Third Parties"), for making City polling place locations accessible on election day. These recommendations were issued on or around May 1, 2010 through July 1, 2010.

The City Defendants are required by Paragraph III.A of the Settlement Agreement to notify the plaintiffs whether the City Defendants accept or reject the recommendations of the

Third Parties for making City polling place locations accessible on election day. The City

Defendants must respond to the Third Parties' recommendations within 45 days of their receipt.<sup>1</sup>

If more than 80 recommendations require a response, the City Defendants must respond to at least 80 recommendations every 45 days until the City Defendants have issued responses to all recommendations that are more than 45 days old.

The City Defendants have responded to 194 recommendations<sup>2</sup> in this report. The City Defendants implemented many of the accepted recommendations for temporary modifications in the April 2012 primary election, even though they were not obligated to do so. Some of the modifications recommended by the Third Parties were already being implemented by the City Defendants well before the Third Parties began evaluating the accessibility of the City's polling place locations.

# II. POLLING PLACES THAT ARE INACCESSIBLE AND SHOULD BE RELOCATED

The following are the City Defendants' responses to recommendations for relocation of polling places.<sup>3</sup>
